## **Stowe Mountain Resort, Vermont**

Skiing at Stowe, Vermont is known for its diverse terrain. Mount Mansfield, Vermont's highest peak, offers long runs and steep trains. Stowe receives consistent high-quality snowfall, average 314 inches per season and has state-of-the-art snowmaking. It has a modern lift system, including gondolas and high-speed quads. Stowe has a vibrant après ski scene with cozy lodges, pubs and restaurants where you can unwind with local craft beers, Vermont-inspired cuisine, and live entertainment.

## Lodging:

The club will be staying at the Green Mountain Inn. The inn is located in the heart of Stowe Village at the intersection of Route 100 and Mountain Road. It is a 15 minute drive to the mountain or take the free shuttle bus that picks up right across the street from the inn.
